FCC Denies Petition for Consideration in Vanity Call Sign Dispute

An Arizona radio amateur has been unsuccessful in convincing the FCC to take a 1 × 2 vanity call sign away from its present holder and grant it to him. In the process, Joshua Babb, K6FZ, may have learned not to rely on informal advice from FCC staffers. Babb, of Maricopa, Arizona, had been **trying** to get the initial-suffix call sign W3JB since 2014, and he was briefly successful. The prior holder of W3JB, John K. Birch, had died, and the 2-year waiting period was set to end on August 18, 2014. Babb filed an application for W3JB in July 2014, however, claiming an exemption to the 2-year waiting period on grounds that he was the deceased licensee's nephew, and the FCC granted it. Subsequently pressed to document that relationship, Babb indicated that Birch actually had been his great-great uncle, the FCC recounted in an **Order on Reconsideration** released on May 25 — a relationship that did not qualify for an exemption.

“Because you did not qualify for the exemption, the [Mobility] Division concluded that you should not have been granted call sign W3JB during the 2-year waiting period,” the FCC told Babb in its *Order*.

The FCC proposed to modify Babb's license by replacing W3JB with KD7HLX, but in September of 2015, Babb filed to swap W3JB for the available K6FZ, which was granted the following month. Under Commission rules, when a call sign is granted in error after the normal 2-year waiting period has ended, it becomes unavailable for 30 days after the erroneous grant is rescinded. The FCC informed Babb of this provision at the time it granted K6FZ, telling him he could reapply.

Babb sought clarification of the W3JB availability date from an FCC staff member, who calculated that it was November 2, 2015. Babb filed two preference-list applications for W3JB on that date as well as one on November 3 and another on November 5. The FCC instead granted W3JB to Scott Phillips of Plano, Texas, who had filed a competing November 3 application and was granted through the FCC's “standard lottery process.” The FCC staffer subsequently informed Babb that his advice had been incorrect, and that November 3 was the correct date.

On December 1, 2015, Babb file a *Petition for Reconsideration* of the grant to Phillips, arguing that, based on his prior staff communication, the call sign should have become available on November 2. The FCC said such a petition “must identify a material error, omission, or other reason that justifies further consideration” and that Babb's *Petition* failed to do so. The FCC said its Universal Licensing System (ULS) had processed the applications correctly.

“[E]rroneous staff advice is not grounds for reconsideration,” the FCC said in its denial *Order*. “Licensees are obligated to know the Commission's rules. It is well established than an applicant acts on staff advice at his own risk.” In any case, the FCC pointed out, Babb nonetheless had filed an application on the correct day.

Why is there no Testing at the Hamfest

There is a simple reason that you will most likely not find VE testing at your local hamfest. If there is testing offered by a hamfest, it is offered at a location other than the hamfest site. There will NOT be any testing at the Firecracker Hamfest / EPA Section convention.

As is written in the Laurel VEC Supplemental Policy to 97.527 this is the part that applies to this situation:

Laurel VE-affiliated VE teams may not administer exams at any event that requires the applicant to pay a fee to gain access to the area where the exam session is held.

Since a fee is charged to enter the hamfest testing simply can not be done.

Special Events to commemorate 70 years as a club

This year Harrisburg Radio Amateurs' Club will be heard on the air as **W3UU/70**. This call will be used with several special event stations that will be on the air throughout the summer and fall.

We will be kicking everything off with a trip to Mt. Davis on Saturday, July 16th. Mt Davis is in the south western corner of Pa, and is the highest point in the state. This site also is a Summits On The Air (SOTA) location and is worth 10 points to those who collect such things. We hope to be on the air from the top of the mountain by 10am Eastern time until about 2pm Eastern time. Listen for us on 7.265 and 14.265, or close to those spots.

The second official Special Event station will be on Saturday, August 13th from the Abandoned Tunnel on the PA Turnpike at the Sideling Hill Tunnel. This, along with another tunnel and about 10 miles of old turnpike were bypassed in 1968. The tunnels were boarded shut, but later opened for testing various road surfaces, paints, and devices. They have since been opened to the general public (and zombies) for walking and bicycling enjoyment. One can always tell if zombies are around because they drag one foot and leave a trail in the dust. Again, we will be using 7.265, and 14.265 mhz, or close to those frequencies.

There will be some short distance events that you will find on the club web site, and on QRZ.com during the coming months. We have found a few SOTA locations close to Harrisburg, and if something comes up that will allow us to show off a bit, we will let you know. A special QSL card will be made for the Tunnel and the Mt. Davis trip, and a special 70th anniversary card will be used for other events this year.

With all of our events, you will find QSL information and directions can be found on QRZ.com, or better yet, on the club site www.w3uu.org. You are all invited to join us on our trips. The plans for meeting everyone will be listed on the club web site. Good hunting and we hope that you find us on the air.



HRAC (W3UU) bonus station for the 2016 PA QSO Party

It may seem early, but the 2016 PA QSO Party will be here before you know it. For 2016, the Harrisburg Radio Amateur Club will be the bonus station for the PA QSO Party, which runs October 8-9. We were selected, in part, due to the successfully innovative bonus station(s) we ran the last time we did this.

The significance of being the bonus station is that each contact with you is worth 200 points, *in addition* to the normal 1 point for SSB and 2 points for CW/Digital. So you become not just one of the in-state “hunted”, you technically become “super hunted”.

So how do we intend to implement this bonus station? There are several options:

1. One station with either a single or multiple transmitters. This is the way bonus stations used to operate until HRAC shook things up with a new idea.
2. One station in each HRAC county. This is what we did last time. We had one station each in Dauphin, Cumberland, Perry and York counties, all signing W3UU/county. This means that the Dauphin county station signed W3UU/DAU, the Cumberland county station signed W3UU/CUM, etc, allowing callers to differentiate among the stations. Everyone could contact each W3UU in the different counties and they could also contact each W3UU on different bands/modes. So you could contact W3UU/DAU on 40 CW, on 40 SSB, on 20 CW, etc. Then do the same for W3UU/CUM, W3UU/PER and W3UU/YOR. We also had a mobile station running around eastern PA, using the same W3UU/county callsign as the fixed stations. One condition was that the mobile station was not allowed to transmit from the counties where we had fixed stations operating.
3. Multiple stations in each HRAC county, operating on different bands/modes. This means that any club member who wants to operate as W3UU/county can do so, there just needs to be coordination among stations within a county as to who operates which band/mode. For example, you could have the following scenario:

W3UU/DAU on 40 (CW and/or SSB), another W3UU/DAU on 20, another W3UU on 80, etc. Or...

W3UU/DAU on CW (any band), another W3UU/DAU on SSB (any band), another W3UU/DAU on digital (any band).

Repeat either scenario with the other counties.

Option 3 also involves the trailer operating from counties outside the fixed station counties, and possibly a mobile station (skeptical on the mobile, but it's possible). You can also look at this option as a large distributed multiple-operator multiple-transmitter operation. You can have a station with beams and amps, or a station with wires or a vertical and no amp (barefoot), it doesn't matter. You'll still be popular, just louder with the first station.

I'd like to do option 3. Yes, it's more complicated and will require scheduling and real-time coordination, but I also see it as more fun. Don't want to operate the full 22 hours of the PA QSO Party? No problem. Pick the hour(s) and band(s)/mode(s) you want to operate and we'll do our best to accommodate everyone.

So that's the initial information on this year's bonus station effort. If you don't know what a QSO party is, there's plenty of time for you to find out. Future newsletters will list major QSO parties being held that month, so you can listen in and get a feel for how these things work. You can even make a few contacts, if you like. We'll also list the significant rules for the PA QSO Party well in advance, so everyone understands what's required.

But the key is to have fun, because if we're not having fun, what's the point? I think we can put together an outstanding effort, but that will rely on the membership. You don't have to be a hard core tester, just someone wanting to give out contacts in one of the more enjoyable contests around.

It is an old picture and lot of equipment has been added.

It has mono band radios for 6,2,220,440 and 1.2 ghz

It has 3 dual band radios, low band for Dauphin County, SGC HF radio and

auto tuner. It has a 440 ATV transceiver and a satellite receiver for 1.2 ghz FM ATV. It has a VHS VCR, a GPS receiver, a small color monitor for use with ATV and the VCR. In the rack there is a GMRS repeater and a two meter repeater. The repeaters are just bolted in the rack and would need re-crystalled and tuned and duplexers if one wanted to try and use them. The truck itself is a 1986 Ford F350 ambulance, with a 460ci engine 4 barrel carb, automatic transmission. The Air conditioning has been removed.
